All submitted documents have to be a copy of the originals and have to be translated into German or English (certified translation):

1. Fully completed and signed application form
2. Personal Information (Upload in one PDF, max. 10 MB):
 - Short commentary on previous artistic work with a maximum of 500 characters (including spaces)
 - Valid photo ID (identity card, passport, or similar)
 - Confirmation of academic semesters ("*Studienzeitbestätigung*")
 - Proof of academic achievement for the last two semesters
 - Last school and/or diploma certificate
3. Confirmation of registration („*Meldezettel*")
4. Financial proof (Upload in einer PDF, max. 10 MB)
 - Consistent and continuous bank account statements for the last 6 months
 - Proof of scholarships received
 - Proof of income (e.g., paycheck/pay stubs) for the last 6 months
 - In case of illness: information on therapy/treatment costs: what type of therapy/treatment are you receiving? Since when? How much do you pay for it and how much is covered by health insurance? (Medical certificate, confirmation of payment of therapy/treatment costs)
